From the Parish Office

Volunteer Sign-in Forms: The new sign-in forms for volunteers are very important and must be filled in now for each volunteer prior to or during each volunteering visit. These must be forwarded to the parish office where these records will be kept for a minimum of 30 days.

Offertory Envelopes: The 2021 Offertory Envelopes are now ready. If you are not currently coming into the church and would like your envelopes before returning, please contact the office. Please note that there are now only 85 envelope boxes for St. Aloysius and 101 boxes for Our Lady Queen of Peace. This means that if you had, for example box #86 in St. Aloysius in the past, it will no longer be possible to have #86 because these box numbers now only go up to #85. This is because many parishioners are now choosing to use other methods to donate including online/automatic withdrawal donations or lump sum donations 1-3 times through the year.

Sunday Missals: Starting on Sunday, November 22nd, Sunday Missals will be available at the back of the church.

Office Visits: If you need to visit the office, please contact the parish office to set up an appointment. Parishioners are also encouraged to make requests via phone or email.

Confessions: If you would like to make a confession, please contact the parish office to set up an appointment with Fr Luis.

Mass Offerings: Mass Offerings may be provided to the office in clearly labelled envelopes sent by way of the collection basket. Also, you have the option of making an appointment to come into the office to arrange a Mass offering.

ANNOUNCEMENT FOR BEFORE/AT MASS

Welcome to the celebration of Mass at our parish! We are working to look after each other's safety and good health during these days of the pandemic. It is our hope that working together, we can stop the spread of this virus and join together in prayer safely.

This announcement is a reminder for all of us. It remains critically important for each of us to continue following the health precautions.

This includes:

- staying home when ill, even with mild symptoms;
- practising physical distancing of 2 metres or 6 feet with those outside your household or social circle;
- protecting your social circle;
- wearing a face covering/mask;
- washing your hands frequently and thoroughly; and
- adhering to gathering limits and rules.



The O. Reg 364/20 became law in the Province of Ontario on October 2, 2020.

This law requires that everyone attending the place of worship (church), **must wear a face covering the entire time** that they are indoors – this includes the celebrant, deacon, and liturgical ministers.

If a person has a health concern related to the wearing of the face mask, the law provides for this exemption to be respected.

This time of uncertainty calls each one of us to renew and amplify our Christian commitment to prayer, reflection, prudent care of each other, and helping others.

Let us continue to pray for those who have died, those who are ill, those who work on the front lines and serve our community, and the ongoing work of medical researchers to discover a vaccine and a cure.

Please Note: A Face Shield is not a Face Mask/Covering because it does not cover the chin. However, in the event of a medical exemption from wearing the face mask/covering, a face shield may provide an alternate option.

REGISTER FOR MASS

We are only permitted to have 30% occupancy during Masses. For St. Aloysius this is forty people – for Our Lady Queen of Peace this is seventy people. We need you to phone or email the office to pre-register for Mass even if you have previously stated that you are coming each week. This will allow us to reserve a seat for you and any guests you may be bringing.

If you do not register for Mass, there is a possibility that you may be turned away if the church has already reached its occupancy (occupancy numbers include those present in the church and also those who pre-registered).

I thank you so much for pre-registering for Mass. It's not just to give us an accurate head count of people who are coming to Mass, but it is a key strategy for preventing further spread of COVID-19 (contact tracing).

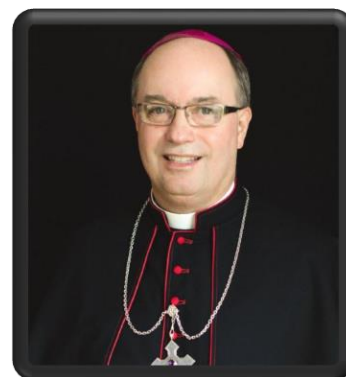

IMPORTANT CHANGES

November 10, 2020

NEW - GOVERNMENT OF ONTARIO FRAMEWORK FOR HEALTH MEASURES

The Government of Ontario has a new framework for the description of COVID-19 health precautions. The Health Unit in each area will determine the level of risk and accordingly, the health precautions to be put in place.





The Framework has five levels: Green – prevent, Yellow – protect, Orange – restrict, Red – control and Lockdown. A description of the five stages in the framework follows. It is the authority and responsibility of the local Health Unit to determine and monitor the stage for their regional jurisdiction. As of November 10, 2020, these designations apply. Check with the local Health Unit for changes after that date.

Permission is now given for the use of a single cantor at Mass.

♣ Group singing is still strongly discouraged.

PARISH BULLETINS & OFFERTORY ENVELOPES

Parishes may prepare paper parish bulletins effective immediately and plan a touchless way to make parish bulletins available to parishioners. Similarly, for the distribution of offertory envelopes, parishes will do so in a manner that avoids touching and the gathering of people around a table.

SUNDAY MISSALS AND MISSALETTES

Parishes can order missals and/or missalettes for parishioners and plan a touchless way to deliver the missals/missalettes. If the parish orders missals/missalettes, follow the same guidelines as noted above for parish bulletins and offertory envelopes. Advise parishioners that paper items left in the church during the pandemic will be collected and put in the recycle bin.

TAKING RISK FACTORS INTO ACCOUNT

The risk factors are used to determine the risk level and need to be mitigated by health precautions.

Risk – Close Contact – Keep a minimum of 6 feet or 2 metres of physical distance from others who are not in your household.

Risk – Closed Spaces – Ensure ventilation and the circulation of the airflow.

Risk - Crowded places – Crowds of people challenge the requirements for physical distancing and make it almost impossible for contact tracing in the event of an infection.

Risk – Prolonged exposure – Proximity lasting more than 15 minutes increases the risk of virus infection.

Risk – Forceful exhalation – The ON Regulation 364/20 requires the wearing of face masks to curtail the spread of droplets from speaking, etc.

CHRISTMAS AND THE SOLEMNITY OF MARY MOTHER OF GOD

The information about Christmas and the Solemnity of Mary Mother of God in this Update is intended to assist parishes with their planning for the Christmas season. It is recognized that things are changing suddenly during this time of pandemic so plans for the Christmas season need to be responsive to the health precautions in place at the time.

DISPENSATION FROM THE OBLIGATION TO ATTEND MASS

Priests and the faithful are reminded that the Dispensation from the obligation to attend Mass remains in effect as follows.

“The obligation to attend Sunday Mass does not apply to those who are ill, especially those who suffer from a contagious illness. Those with flu-like symptoms should remain at home in order not to spread the virus to others.” – +Most Reverend Bishop Miehm, March 13, 2020, COVID-19 Update #1

“During this period of transition, I continue to dispense the faithful from the obligation to attend Sunday Mass. Those most at risk because of advanced age or compromised health should consider not attending Mass during this time, or attending only weekday celebrations of the Mass when participants are fewer.” - Letter from +Most Reverend Bishop Miehm to the Faithful, June 10, 2020

“This Dispensation also applies to Christmas and the Solemnity of Mary Mother of God.” - +Bishop Miehm, November 10, 2020.

HOW MANY MASSES CAN A PRIEST CELEBRATE AT CHRISTMAS?

An individual priest may celebrate up to three Masses on Christmas Eve and three Masses on Christmas Day, as needed. If a priest needs to celebrate more than three masses in a day, contact the Chancellor of Spiritual Affairs to request a dispensation from the Bishop. The applicable canons and commentary are quoted below.

Can. 905 §1. A priest is not permitted to celebrate the Eucharist more than once a day except in cases where the law permits him to celebrate or concelebrate more than once on the same day.

§2. If there is a shortage of priests, the local ordinary can allow priests to celebrate twice a day for a just cause, or if pastoral necessity requires it, even three times on Sundays and holy days of obligation.

“The Bishop may permit priests to trinate, i.e. celebrate three times, on Sundays or holydays of obligation. The Ordinary may not give a broader faculty than is permitted in this canon without permission of the Holy See. However, in an individual case and for sufficient reason, a diocesan

bishop could dispense from this canon in virtue of can. 87, §1." Source -*The Canon Law Letter and Spirit; A Practical Guide to the Code of Canon Law*, The Canon Law Society Trust, 1995, pp. 497-498.

WHEN CAN THE CHRISTMAS EVE MASS SCHEDULE BEGIN?

Pope Pius XII's Apostolic Constitution *Christus Dominus* (Jan. 6, 1953) states that an evening Mass on the day before a Sunday or Holy Day should not begin before 4:00 p.m.

WHAT IF THE PARISH NEEDS TO BEGIN THE CHRISTMAS EVE MASS SCHEDULE EARLIER?

Diocesan bishops can dispense from universal disciplinary laws (see canon 87) provided it contributes to the spiritual good of the faithful. The timing of Mass is a disciplinary matter. If it is necessary to begin the Christmas Eve mass schedule before 4:00 p.m. on December 24th, 2020, contact the Chancellor of Spiritual Affairs to request a dispensation from the Bishop.

WHAT IF I NEED ASSISTANCE?

Contact the Chancellor of Spiritual Affairs to arrange for the assistance priests need for the Mass celebration schedule at the parishes during the Christmas season.



HEALTH PRECAUTIONS IN OUR PARISHES

- Safely determine 1/3 capacity of a church
- Sanitize and be vigilant about the hygiene practices at the church
- Post signage for the wearing of face masks, entrances, exits, use of hand sanitizers, etc.
- Establish distinct doorways for entering and exiting
- Ask ushers to seat parishioners so that physical distance is maintained.
- Make the Diocesan announcement before the weekend Masses during the pandemic.
- REVISED – Follow safe health precautions for singing at Masses.
- Instruct parishioners about clear procedures for the distribution of Holy Communion
- Face masks are now required in places of worship and work sites in the province of Ontario. Make sure signage is posted, priest is wearing the mask when he is not speaking/singing, the parishioners are verbally reminded to wear mask and have a supply of face masks on hand in case parishioners have forgotten to bring a face mask. (Those who have a medical exemption from wearing the face mask are to be respected and welcomed.)
